**Introduction**

**WHEREAS:** Gutierrez Empire promote the Law as known as Nation and State Empire/Imperialism of the Philippine/ **“PHILIPPINE EMPIRE”** /National Empire, Empire of Rulers, and Imperialism Governance of the Nation’s and Government and Society & New Generation Universal Imperialism and World State and Nation Imperialism/Empire”.

**WHEREAS:** To serve as Strengthening of the individual human rights of Jorge Marlo Mira Gutierrez and his family, obtaining his rights in the Philippine, as one of filipino citizen and as a bearer of Gutierrez Family name means he who rule and to other Gutierrez Family name who wants to reconnect or cooperate and with respect to Article XV sec 1 of our constitution as the family as the foundation of our nation, to rule and established the monarchy foundation also in Philippine or known as Philippine monarchy and strenghten the rights of nobility in Philippine under in name of Gutierrez Empire and Philippine Empire and his laws and monarchy.

**WHEREAS:** To work and support the Philippine Empire and his Constitution propose in the Philippine.

**WHEREAS:** To serve as a legal documents act and law of establishing the Philippine Empire Incorporated.

**WHEREAS:** The Gutierrez Empire, Philippine Empire and Kingdom of Philippine established as of one part and single administrative, or administration in government, organizations, society and community following the republic-democratic monarchy government as recognize in section 2 of Gutierrez empire law to respect and honor some people or filipinos and families who still value and give and believing the importance in rights of nobility or being noble, and still practice the monarchy in Nation as propose and to be established or given by government in respect of their rights as a citizen and individual in the Republic of the Philippine and Government as also a democratic government which a government give more importance of control of people and their rights.

## **PREAMBLE**

We the Filipino Empire and Kingdom people, earnestly asking for aid and guidance of Almighty God. That Honor, Respect, Loyal to empire and kingdom, Trust, Love, Care, and protect, Recognize, believe in our Rulers and maintain Peace and understanding, unity, equality, security and help in each other needs and in order to established a Empire and Kingdom and his Government administration that will help our nations interest and purpose.

### **Title I**

#### **PHILIPPINE EMPIRE POLICY**

##### **Chapter I**

##### **Article I**

#### **BASIC PROVISION**

##### **Section 1**

**Title: STRENGTHENING THE PHILIPPINE EMPIRE UNDER BY GUTIERREZ EMPIRE AND STRENGTHENING THE SUPPORT OF PHILIPPINE EMPIRE CONSTITUTION AND FOR OTHER PURPOSES.**

##### **Section 2**

##### **Definition of Terms**

1. "Philippine Empire people" shall mean as the Filipino people and citizen of Philippine and/or any people under by sovereignty and authority of Philippine.
2. "Crown" shall mean his highness the Emperor of Gutierrez Empire and Philippine.
3. "Arm Forces of the Crown" shall mean as the Royal Arm Forces of the Philippine or Royal Military of the Philippine.
4. "Officer of the Crown" shall mean as the servants of his highness the emperor, nobles of empire and kingdom.
5. "Crown court" shall mean as the house of lords of Gutierrez Empire and the lower court of Philippine Empire.
6. "Crown Upper Court" shall mean as the house of lords of Gutierrez Empire
7. "Crown lower Court" shall mean as the lower court or commons court or house of commons of Philippine Empire
8. "Royal" shall mean as refer to an honorable and respect title and name and royalty of a monarch and in Philippine Empire and Kingdom of Philippine royalty, and a name use to respect and honored the royal family, or to whoever subjected monarchy in the world that has the right and authority in Philippine (*e.g. United Kingdom, or Kingdom of Spain or Maharlika, etc.*)
9. "Gutierrezcratic Empire" shall mean as the Imperialcracy or Empirecracy of Nation (Philippine) or Imperialism of Government of the Nation (Philippine) a form of imperialism and Government

imperialism where the Nation (Philippine) Empire noble ranks shall have the same title and position and power of the Government Officials in Nation (Philippine) Government.

### Section 3

#### Declaration and policy

1. To declare and/or that there shall be a Philippine Empire Inc. As serve as institution and organization, society and community of Philippine Empire movement in the Philippine under by Gutierrez Empire.
2. To declare, Recognize and there shall be a Philippine nobility and/or Filipinos nobility under by Philippine Empire nobility.
3. To Declare the Philippine Empire and Kingdom of Philippine monarchy to be the center monarchy of Philippine and under by Gutierrez Empire monarchy in the Philippine.
4. To propose and uphold the Gutierrez Empire Strengthening law as World State and Nation Empire or World State and Nation National Empire under their Nation or countries name and empire, incorporated in the world (*e.g. American Empire Inc in USA*). – in respect and recognize in Section 2 no. 6 in Gutierrez Empire law.
5. To declare and promote The Gutierrez Empire, Philippine Empire, Kingdom of Gutierrez and Kingdom of Philippine established as of one part and single administrative, or administration in government, organizations, society and community following the republic-democratic monarchy government as recognize in section 2 of Gutierrez empire law in respect and honor of some people or filipinos and families that still value and give and believing the importance in rights of nobility or being noble, and still practice the monarchy in Nation in respect of their rights as a citizen and individual and cooperation or unity and understanding or following under in the Republic of the Philippine constitution or law and Government as also a democratic government.
6. To Declare and/or there shall be a Kingdom of Philippine Inc as under Organization, institution of Philippine Empire Inc.
7. And other as may provided by law.

## **Title II**

### **Chapter 2**

#### **Article 2**

#### **EMPIRE**

#### **Section 4**

##### **DECLARATION OF POLICY**

1. The Philippine Empire is a democratic and republican Empire. Sovereignty resides in the people and all government authority emanates from them.
2. The Philippine Empire society is the Nation and state society of the Philippine under by the law of Kontrolerism Society in the Philippine
3. And other as may provided by law.

#### **Section 5**

##### **Territory**

Philippine Empire Area of plebiscite is the Kingdom of Philippine comprises the Philippine archipelago, with all the islands and waters embraced therein, and all other territories over which the Philippines has sovereignty or jurisdiction, consisting of its terrestrial, fluvial and aerial domains, including its territorial sea, the seabed, the subsoil, the insular shelves, and other submarine areas. The waters around, between, and connecting the islands of the archipelago, regardless of their breadth and dimensions, form part of the internal waters of the Philippines.

*Refer to the area of territory of Republic of Philippine Constitution and propose Philippine Empire and Kingdom of Philippine Constitution*

#### **Section 6**

##### **Function and Responsibility of Empire**

*In respect and as recognize of the Function and responsibility of Emperor of Gutierrez Empire found on Article III section 5 of Gutierrez Empire Republic Act.*

1. One Council or committee and administration of Government
2. One that is representative of Government and State and other foreign administration
3. Monarchy representative of Philippine



4. A monarch Government administration that maintain Local Diplomacy and family and state affairs
5. A monarch Government administration that One that Approve regulations, implementation, rulemaking, when it comes diplomatic relations, Military, territorial, Constitutional or law considered to be highly and nationally constitutional law - this refer to constitution law of Nation, and currencies, cultural traditions and others
6. One administrative that Promulgate law and administer Justice
7. Military Council and committee and adviser of Department of National Defense and Arm Forces of the Philippine.
8. Serve in any governmental, public and security matters of state, stipulated by law, and/or that advice or approval of cabinet
9. A Monarch Government administration, Organization, society and community represent, typify or epitomize and symbolize the unification or union, integrity, wholeness and oneness of Nation, Government, and their administration, organization, society or groups and community and State and family and people or citizens and military.
10. Maintain Peace and order
11. and other political service as may provide and authorize by law

### **Chapter 3**

#### **Article 3**

#### **NOBLES RANKS AND TITLES**

##### **Section 7**

##### **DECLARATION OF POLICY**

1. To declare and/or that there shall be a Philippine Empire, Imperialism nobility and noble ranks or officials or also known as Kingdom of Philippine nobles ranks and nobility.
  - *In respect to no. 2 of the declaration policy of this provisions and act.*
2. To Declare and recognize the Philippine Empire nobility and nobles ranks are the following;
  - i. Emperor – the overall head commanding person and head and most honorable person of Philippine Empire and nobility.
  - ii. Empress – the wife of emperor and honorable person in empire.
  - iii. Imperial Prince – a son of Emperor and honorable person in Empire.
  - iv. Imperial Princess – a daughter of Emperor and a related and close family members and honorable person in empire.
  - v. King or High King or also known as emperor King for Empire title or King Emperor for Kingdom Title – as serve the second title or other title hold by Emepror of Philippine, means the King of Kingdom of Philippine

- vi. Queen or also known as Empress Queen for Empire title or Queen Empress for Kingdom Title – as serve as the second title or other title hold by Empress of Philippine, means the queen of Kingdom of Philippine and wife of the King.
  - vii. Prince – a son of King and honorable person of Kingdom
  - viii. Princess – a daughter of the King and related and close family members honorable person of Kingdom
  - ix. Duke – serve as fourth rank noble to emperor head in-charge of services of the empire and emperor responsibility.
  - x. Duchess – wife of duke and a related and close family members of emperors and honorable person of Empire
  - xi. Marquess – serve as the fifth ranks noble to emperor and honorable person of Empire
  - xii. Lords – serve as the sixth ranks noble to emperor and honorable person of Empire.
  - xiii. Earl or counts – serve as the seventh ranks noble to emperor and honorable person of empire.
  - xiv. Baron – serve as the eight ranks noble to emperor and honorable person of empire
  - xv. Knights – serve as the military and soldier of empire, protector and guardian of emperor's family and empire and honorable person of empire.
3. Other as may provided by law.

## **EMPEROR**

### **Section 8**

#### **EMPEROR, Declaration of Policy**

1. To declare and/or there shall be an emperor of Philippine Empire, or Emperor King or High King Emperor as a head of Philippine Empire and Kingdom of Philippine nobility.
2. To declare the Emperor of Gutierrez Empire to be the Emperor of Philippine Empire
3. To Declare the King of Kingdom of Gutierrez to be the King of Kingdom of Philippine
4. To Declare the Emperor of Gutierrez Empire to be the Emperor of Philippine Empire and King of Kingdom of Gutierrez and King of Kingdom of Philippine as recognize an respect in Gutierrez Empire law.
5. To declare Emperor and King Jorge Marlo or known as Emperor or Emperor King (for empire) or King Emperor (for Kingdom) Jorge Marlo Mira Gutierrez as the first emperor of Philippine Empire and High King of Kingdom of Philippine
6. His title as of the Emperor of Philippine and High King of Philippine or also known as Emperor King (for empire) or King Emperor (for Kingdom) of Philippine

7. To Declare the Philippine Empire Emperor and King is the one who Act as a represent, typify or epitomize and symbolize the unification or union, integrity, wholeness and oneness of Philippine Empire people.
8. Other as may provided by law.

## **Section 9**

### **Function and responsibility**

#### **1. EMPEROR Function and responsibility**

*In respect and as recognize of the Function and responsibility of Emperor of Gutierrez Empire found on Article III section 7 of Gutierrez Empire Republic Act.*

#### **Function and Responsibility are of following:**

- i. Adviser and one councilor of the President of Nation
- ii. Nation, Government and State Representative and other Foreign Affairs
- iii. Maintain Monarchy family and diplomatic relations to other Nation
- iv. Monarch family representative of the Philippine
- v. Maintain Local diplomacy and Family and state Affairs
- vi. One that Approve regulations, implementation, rulemaking, when it comes diplomatic relations, Military, territorial, Constitutional or law considered to be highly and nationally constitutional law - this refer to constitution law of Nation, and currencies, cultural traditions and others.
- vii. Promulgate law and administer Justice
- viii. Adviser to Acting head Commanding General of Arm Forces
- ix. Diplomat
- x. Perform Acts in matters of state, stipulated by law, or that advice or approval of cabinet
- xi. Act as a represent, typify or epitomize and symbolize the unification or union, integrity, wholeness and oneness of people and State and family.
- xii. Maintain peace and order of Empire and under Kingdom
- xiii. Priority and Highly recommended appointee and/or act as appointee Secretary of Department of Society upon the approval on Commission of Appointee, - *under respect of establishment of Department of Society, under by propose law of Nation and State Society of the Philippine – under by Kontrolerism society.*
- xiv. Act or priority and Highly recommended as a chairman and/or president of Gutierrezcracy Government and administration and member of board and recommended head officials or officials of Bureau of Currency -*under respect of establishment of Gutierrezcracy Government and his administrative office known as Bureau of Currency, under by propose law of Government and administration Run by Currency of Nation – under by Gutierrezcracy Government and Administration.*
- xv. and other political service as may provide and authorize by law

## Section 10

### Crown

1. The Crown of Philippine Empire shall be inherited by the successor of Emperor and King Jorge Marlo Mira Gutierrez, the founder of Gutierrez Empire and Philippine Empire and Kingdom of Philippine in Philippine and first emperor and king of Philippine, as also a political empire, which is to be remain unchangeable and part of historical of our nation as long as this law valid and recognize, and the empire and kingdom exist if it is either constitutional, real and in the will of people who believe on it. The Succession to the throne follow the regular order of primogeniture and representation, follow the tradition of succession, that the first line always having preferences over subsequent lines; within the same line, the closer grade over the more remote; within the same grade, the male over the female and in the same sex, the elder over the younger.
2. The Crown Prince, from his birth or from the time he acquires the claim, shall hold the title of Prince of Filipinas (Philippine) or Filipino's, and the other titles traditional held by the heir to the crown of Philippine.
3. if all the lines designated by law become extinct, the House of Senate and with the approval of the President and solicitor general and vote of cardinal of philippine upon the recommendation of House of Lords of Gutierrez Empire shall provide for succession to the crown in the manner most suitable to the interest of Philippine, The Recommendation of house of lords of Gutierrez Empire to the senate if all lines designated by law become extinct must be a Gutierrez Family name bearer.
4. Abdication and renunciation and any doubt in fact or in law that may arise in connection with the succession to the crown shall be settle under by house of lords.
5. In the event of the Emperor being under age, the emperor parents (mother and father) or, in default thereof, the oldest relative of legal age who is nearest in succession to the crown, shall immediately assume the office of regent, which shall exercise during the emperor minority.
6. If there is no person entitle to assume the regency, it shall appointed temporarily by house of lords and shall be compose of two, three or seven persons.
7. In order to exercise the regency, he/she must be a filipino, legally age and Gutierrez family name and related.
8. The emperor on being proclaimed will swear to faithfully carry out his duties, to obey the constitution and the laws and ensure that they are obeyed, and to respect the rights of citizen or Gutierrez and Philippine Empire people.
9. The Crown prince, on coming of age, and the regent or regents, on assuming office, will swear the same oath as well that of loyalty to the emperor.

10. The emperor receives an enough amount from the imperial, Kingdom or Government budget and allowance for the maintenance of his family and households and others expenses and distribute it freely.
11. The emperor freely appoints and dismisses Royal Military members of his households.
12. If the next successor of the crown is emperor his wife receives the title of empress, and if the next successor of crown is empress his husband receive the title of a Imperial Prince.
13. Other as may provided by law.

## Section 11

### Nobles function and responsibility

1. Act as a representative of emperor-king, typify or epitomize and symbolize the unification or union, integrity, wholeness and oneness of people and family in their respective places and areas.
2. Protect and support and serve the emperor-king and empire interest in any means necessary.
3. Carry out emperor some services temporarily upon the absence of emperor-king, or if the emperor-king cannot carry the services in such a time.
4. Priority recommended appointee and/or act as appointee heads officers/officials and chairperson of local society offices upon the approval of Department of Society under by secretarial services and/or Emperor-King as also an appointee Secretary of Department of Society, - *under respect of establishment of Department of Society and his organization and function in local services nationwide, under by propose law of Nation and State Society of the Philippine – under by Kontrollerism society.*
5. Other as may provided by law.

## Section 12

### Duties and Responsibility and function of nobles

#### 1. Duties and Responsibility and function of nobles in Government;

- i. May be Serve as an officials of government upon the vote of the people, participated and included in common election, under and by following and with respect in the rules of gutierrezcratic form of government service.

#### This are of the following;

- ii. Recognize as honorable person of government and people.
- iii. Serve as an adviser and councilors of government officials of their respective places

## **2. Duties and Responsibility and function of nobles in Military;**

- i. Serve as adviser and councilor of generals
- ii. May be Serve as an officials of Military forces
- iii. Other as may provided by law.

## **3. Duties and Responsibility and function of nobles in State and Society;**

- i. Act as a representative of emperor-king, typify or epitomize and symbolize the unification or union, integrity, wholeness and oneness of people and family in their respective places and areas. – *in respect in section 9. No. 2 on this act*
- ii. Other as may provided by law.

## **4. Duties and Responsibility and function of nobles in Religion;**

- i. Act as a true bearer and one representative of religions faith upon and with the approval of their religions leaders (e.g. priest etc.) in their respective places.
- ii. Other as may provided by the law.

## **Section 13**

### **Rights**

#### **1. Human Rights**

- i. The Philippine Empire and Kingdom of Philippine values the dignity of every members and Philippine Empire and Kingdom of Philippine nobles people's and guarantees the full respect for human rights. *In respect and recognize in Section 12 no. 1 in Gutierrez Empire Republic Act.*
- ii. Philippine Empire and Kingdom of Philippine nobles and people will recognize to promote a just dynamic social order that will ensure the prosperity and independence of the society and free the Gutierrez Empire and Kingdom of Gutierrez, Philippine Empire

and Kingdom of Philippine people from poverty through policies that adequate social services, promote full employment and rising standard of living and improved quality of life for all and social justice in all phases of World or Worldwide and Global International Development. *In respect and recognize in Section 2 no. 3 in Gutierrez Empire Republic Act and constitution.*

- iii. Other as may provided by law.

## **2. Royalty Rights**

- i. Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine nobles and/or nobility has the rights to be honored and respect by the citizen of Nation.
- ii. Other as may provided by law.

## **Section 14**

### **Nobility Crown**

1. The Noble title or rank of Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine nobility members or the nobles shall be inherited by the successor of their family or the person entitle or holder of it, The Succession to the nobles title or rank of Philippine Empire and Kingdom of Philippine nobility follow the regular order of primogeniture and representation, follow the tradition of succession, that the first line always having preferences over subsequent lines; within the same line, the closer grade over the more remote; within the same grade, the male over the female and in the same sex, the elder over the younger.
2. if all the lines designated by law become extinct, the House of lords and with the approval of the Emperor shall provide for succession to the crown in the manner most suitable to the interest of Philippine Empire and Kingdom of Philippine nobility.
3. In the event of the Noble title successor is being under age, the Nobles successor parents (mother and father) or, in default thereof, the oldest relative of legal age who is nearest in succession to the title, shall immediately assume the title, which shall exercise during the noble successor minority.
4. If the noble title bearer becomes unfit for the exercise of his authority and title or rigts, and this is seen and recognized by house of lords, the noble eldest son or next successor shall immediately assume the regency, if he is of age.
5. If the noble hold the title of a Duke his son will hold the title of a prince and his daughter will hold the title of a princess.
6. And other as may provided by law.

## **Section 15**

### **Marriage**

#### **1. Marriage**

- i. To declare the marriage's of Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine nobles as also known as the Royal Marriage's.
- ii. Royal Marriage's shall have full respect and follow and obey the law of Marriage of the Nation.
- iii. Member of emperor family must ask permission to the emperor before marrying someone.
- iv. Emperor-king family and other Nobles must only marry a noble person, if or should marry a non noble or commoner or foreigner it must be ask permission and approved or authorize by the house of lords.
- v. Common people, non-noble or foreigner marry a noble person in the Empire or Kingdom is already considered a noble person and hold the title of nobility of the family.
- vi. Common people, non-noble or foreigner that marry a noble person and already given or holds the title of nobility must be registered in the bureau of nobility.
- vii. Refuse or deny to follow the above Royal Marriage law (i to vi), there marriage will be not valid and not considered and/or shall be void.
- viii. And other as may provided by law.

## **Section 16**

### **Tradition and his laws and rules**

This is to allow the Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine to have and follow and practice Family, Imperial and Kingdom etiquette practices for nobility or nobles act.

#### **This are the following;**

1. Optional to Vote in Government Election – allow and practice in Emperor-King Family only. – Emperor-King and Family has their choices to vote or not in Government Election.
2. The Emperor-King and Empress-Queen can only sit on their own throne.
3. Sons and Daughters of Emperor-King must allow to travel when they come to 18 years old.
4. Two are not allowed to travel together until their legally age.
5. Dress appropriately
6. Bowing and Curtsying is important as a symbol of Honor and respect.
7. The Emperor-King Family isn't allowed to sign autograph or take selfies
8. The Family must accept gifts.
9. Other as may provided by Empire and Kingdom or by law.

#### **Creating the Bureau of Nation and State Empire Of Philippine**

##### **Section 17**

###### **Title**

Bureau of Nation and State Empire, BNSE shall known as the Bureau of Nation and State Empire of the Philippine, An administrative Government agencies in-charge of admenistering and/or governing the Philippine Empire and Imperialism in the Philippine.

##### **Section 18**

###### **Declaration of Policy**

1. To Declare and/or there shall be a Bureau of Nation and State Empire, BNSE as an administrative agencies in-charge of admenistering and/or governing the the Philippine Empire and Kingdom of Philippine and Imperialism in the Philippine.
2. Other as may provided by law.

##### **Section 19**

###### **Officials**

1. The Bureau of Nation and State Empire shall compose of Chairperson as also holder of the position and title of Emperor and King, President as also holder of the position and title of Duke, Vice President as also holder of the position and title of Duke and the Director's as holder of the position and title of lords.
2. The Chairperson of Bureau of Nation and State Empire is the Emperor and King of Philippine Empire and Kingdom of Philippine.
3. The President of Bureau of Nation and State Empire shall be appointed by the Chairperson.
4. The Vice President of BNSE shall be appointed by the President of BNSE.
5. The Director's of Bureau of Nation and State Empire shall be appointed by the house of lords.

## **Section 20**

### **Function of BNSE**

1. To serve as the governing body and/or administrative government office of the Philippine Empire Inc. And Kingdom of Philippine Inc.
2. To maintain peace and order in empire and/or Kingdom.
3. To enforce and promulgate rules and law and administer justice.
4. Other as may provided by law.

## **Section 21**

### **Mission and Vision**

#### **Mission**

Bureau of Nation and State Empire establish as a National Office of Philippine Empire and Kingdom of Philippine, in overall admenistering and governing the Philippine Empire and Kingdom of Philippine people in matter of nobility, royalty, livings, rights, security and protection, affairs etc.

#### **Vision**

Bureau of Nation and State Empire invision as a honorably authoritative office and agencies of Philippine Empire and his people, and one of leading and respected agencies in government of Philippine.

## **LEGISLATIVE**

### **DECLARATION OF POLICY**

## **Section 22**

Creating the Legislative Branch of Bureau of Nation and State Empire, under by Philippine Empire and Kingdom of Philippine.

1. *To Declare and/or there shall be a Legislative branch of Philippine Empire, BNSE, The Legislative Branch of Philippine Empire, Bureau of Nation and State Empire shall be vested in the Council of Philippine Empire and Kingdom of Philippine which shall consist of House of Lords as the upper council and House of Commons as the lower and second council.*
2. Other as may provided by law

## **HOUSE OF LORDS**

### **Section 23**

#### **Declaration of Policy**

1. To Declare and/or there shall be a House of Lords as the upper council of Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine.
2. To Declare the house of lords as an attached council to the Bureau of Nation and State Empire, but under by the authoritative of Gutierrez Empire.
3. And other as may provided by law.

### **Section 24**

#### **Members**

The House of Lords members shall compose of 30 lords, which is representative of regions lords and others families and places in nation as may provided by law.

### **Section 25**

#### **Function of House of Lords**

1. To evaluate the rules, treaties propose by emperor and other parties.
2. Has the authority to confirm the emperor choices for diplomats, dukes or lords, council members, and other important nobles and officials.
3. also conducts removal of titles and names and position hearings against the nobles, after the house of commons has voted to proceed the removal or impeachment.
4. Conducts hearing about issue of nobility titles names and position.
5. To approved and organized Houses committees
6. Has the power to amend the laws of Empire and Kingdom.
7. Other as may provided by law.

## **HOUSE OF COMMONS**

### **Section 26**

#### **Declaration of Policy**

1. To Declare and/or there shall be a House of Commons as the lower council of Philippine Empire and Kingdom of Philippine.
2. To Declare the house of Commons as an official council of Philippine Empire and kingdom of Philippine, and under by the authoritative of Gutierrez Empire.
3. And other as may provided by law.

## **Section 27**

### **Members**

The House of commons members shall compose of 150 lords or barons and marquess, which is representative of provinces lords and barons and markees'es and others families and places in nation as may provided by law.

## **Section 28**

### **Function of House of Commons**

1. Has the authority to make all nobility laws which shall be necessary and proper, and to be approved by Emperor.
2. holds hearings on matters of Philippine Empire and Kingdom of Philippines governance and nobles or nobility and commoners or public concern and to raise Empire and Kingdom and public awareness about an issue.
3. Other as may provided by law.

## **Section 29**

### **Declaration of Policy**

1. *To Declare and/or there shall be a Executive Branch of Philippine Empire and Kingdom of Philippine, BNSE, The Executive branch of Philippine Empire and kingdom of Philippine is the one branch of Philippine Empire and Kingdom of Philippine, BNSE in-charge of administering and enforcing the Philippine Empire and Kingdom of Philippine Laws written by the Philippine Empire house of commons Council and approved by the Emperor.*

### **CREATING OF EXECUTIVE BUREAU'S OF PHILIPPINE EMPIRE AND KINGDOM OF PHILIPPINE**

### **CREATING OF BUREAU OF STATE EMPIRE**

## **Section 30**

### **Title**

Bureau of State Empire shall known as Office or Bureau of State Empire of the Philippine, and Governance administrative office of Bureau of Nation and State Empire in-charge of handling, admenistering the Governance of Local State of Empire in every regions, states and provinces area in the Philippine.

1. To Declare and/or there shall be a Bureau of State Empire, one of under bureaus of Bureau of Nation and State Empire as a governance of Local State Empire in every regions, states and provinces area in the Philippine.
2. Other as may provided by law.

Bureau of State Empire is compose of Director and also holder of title and position of Duke and assistant Director and also holder of title and position of a Lord, appointed by house of lords and approved by emperor.

## **Section 33**

### **Function of Bureau of State Empire**

1. To serve as the administrative local office of Philippine Empire and Kingdom of Philippine in regions.
2. Other as may provided by law.

## **Section 34**

### **Mission and Vision**

#### **Mission**

Bureau of State Empire established as a local office of Philippine Empire and Kingdom of Philippine, in-charge of admenistering local issues and concern related to nobility, royalty, or members families affairs in local areas in Philippine.

#### **Vision**

Bureau of State Empire envision as a firm local office of state empire in the Philippine.

## **CREATING OF BUREAU OF NOBILITY**

Bureau of Nobility shall be known as Office or Bureau of Nobility of the Philippine, as one of executive bureau's and Office of Bureau of Nation and State Empire, in-charge of admenistering the nobility of filipinos and nobility of Philippine Empire and Kingdom of Philippine.

2. To conduct envistigation regarding on affairs of nobles and/or nobility in empire and/or Kingdom, that may result and affect in person nobility.

2. To enforce rules in matter of royalty affairs.
3. To promote and maintain proper royalty affairs.

1. To Declare and/or there shall be a Bureau of Royal Education as an administrative office in-charge of nobles and royalty Education in Philippine Empire and Kingdom of Philippine.

1. To Declare and/or there shall be a Bureau of Noble Organization and Society as an administrative office in-charge of nobles and royalty Organization and Society in Philippine Empire and Kingdom of Philippine.
2. To Declare and recognize the Nobles and Royalty Organizations and Society as a social, organization, society, institution and community and been respectfully and honored in Philippine Society and community.

Royal Bank of Philippine, RBP shall be known as Royalty Bank of the Philippine, an Universal Bank of royalty and nobles in Philippine Empire and Kingdom of Philippine.

### **Declaration of Policy**

1. To Declare and/or there shall be a Royal Bank of Philippine, RBP as an Universal Bank of royalty and nobles in Philippine Empire and Kingdom of Philippine.
2. To Declare the Royal Bank of Philippine as the Government Bank of Philippine.

## **Section 57**

### **Officials**

Royal Bank of Philippine, RBP is compose of Director and also holder of title and position of Duke and assistant Director and also holder of title and position of a Lord, appointed by house of lords and approved by emperor.

1. Serve as a center bank of Philippine Empire and Kingdom of Philippine people and other people and citizen of nations.

1. *To declare and/or there shall be a Judicial Branch of Philippine Empire and Kingdom of Philippine, BNSE, The Judicial branch of Philippine Empire and Kingdom of Philippine is the one branch of Philippine Empire and Kingdom of Philippine, BNSE in-charge of administering and dispensing justice.*
2. Other as may provided by law.

## ROYAL COURT OF JUSTICE

### Section 60

#### Declaration of Policy

1. The Judicial Branch Power of Philippine Empire and Kingdom of Philippine shall be vested in Royal Court of Justice and other lower court.
2. To Declare and/or There shall be a Royal Court of Justice, The court of justice in-charge of administering and dispensing justices of royalty and nobles in Philippine Empire and Kingdom of Philippine and other people and citizen of Nation.
3. Royal Court of Justice is a court of justice attached to supreme court and ombudsman as may provided and authorize by law.
4. The Royal Court of Justice shall compose of Royal Chief Justice as also holder of the position of a Duke and 10 Associate Justice as also holder of the position of marquesses or more as may provided and authorize by law.
5. The Royal Court of Justice, Royal Chief Justice is the one of associate justice of Supreme Court and must be a member and registered nobles and royalty of Philippine Empire and Kingdom of Philippine and appointed by the Emperor-King of Philippine Empire and Kingdom of Philippine.
6. Other as may provided by law.

### Section 61

#### Functions

1. Decides cases arising under Philippine Empire and Kingdom of Philippine laws and under the Constitution of Philippine.

2. interprets laws, rules that have been passed by the legislative branch (House of Lords) and approved by the Emperor and other Executives Bureaus Actions.
3. the power to hear appeals of cases decided in house of Lords and house of Commons and other courts as may permitted and authorized by the law.
4. Heard all cases involving constitutionality of treaty, International or executive agreement, or law and other cases that under the rules of court, including application or operation of Imperial and/or kingdom decrees, nobles, royalty Proclamation, orders, instructions, ordinance and other regulation, and shall be decided with the concurrence of Judicial members that will took part in the deliberations on the issues in the case and voted thereon.

1. To Declare and/or there shall be a Royal Military or known as Royal Military of the Philippine or Arm Forces of the crown an attached arm forces in Arm Forces of the Philippine and under in highly and head reserve forces and special unit of Arm Forces of the Philippine (AFP).
2. Royal Military or the Arm Forces of the Crown is headed by commanding general and emperor and king of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
3. Royal Military or Arm Forces of the Crown compose of the following;

- i. **Royal Guards** – A Highly and honored Reserve Military and Special Unit Arm forces of Arm Forces of the Philippine (AFP) in-charge as a Royal Guards or Guardians soldier and own or personal or private protector, security of Emperor and King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Emperor-king Royal Knights Guardians”.

**Function and Responsibility;**

- (i) Private and Personal Arm Forces of the Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
- (ii) Guardians, Protector and Security of Emperor-king families and places.
- (iii) Other as may provided by law

- ii. **Royal Army** – A Highly and honored Reserve Military and Special Unit Arm forces of Arm Forces of the Philippine (AFP), under by Philippine Army (PA) in-charge as a Royal Army or soldier and personal or private or own Army Forces of Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Philippine Royal Knights Army”.

**Function and Responsibility;**

- (i) Serve as the Army Forces of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
- (ii) Protector and Security of Land territory of Philippine Empire and Kingdom of Philippine, under by territory as recognize in section 2 on this constitution.
- (iii) Defend the Gutierrez Empire, Philippine Empire and Kingdom of Philippine and protecting its interest, principle and people.
- (iv) Helping communities from problems, natural calamities, providing security at event of empire and kingdom.
- (v) Other as may provided by law.

- iii. **Royal Navy** - A Highly and honored Reserve Military and Special Unit Arm forces of Arm Forces of the Philippine (AFP), under by Philippine Navy (PN) in-charge as a Royal Navy or soldier and personal or private or own Navy Forces of Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Philippine Royal Knights Navy”.

**Function and Responsibility;**

- (i) Serve as the Navy Forces of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
- (ii) Protector and Security of Water territory of Philippine Empire and Kingdom of Philippine, under by territory as recognize in section 2 on this constitution.
- (iii) Other as may provided by law.

- iv. **Royal Air Force** - A Highly and honored Reserve Military and Special Unit Arm forces of Arm Forces of the Philippine (AFP), under by Philippine Air Force (PAF) in-charge as a Royal Air Force or soldier and personal or private or own Navy Forces of Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Philippine Royal Knights Navy”.

**Function and Responsibility;**

- (i) Serve as the Air Forces of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
  - (ii) Protector and Security of Air territory of Philippine Empire and Kingdom of Philippine, under by territory as recognize in section 2 on this constitution.
  - (iii) Other as may provided by law.
- v. **Royal Intelligence** - A Highly and honored Reserve Military Forces and Special Unit Arm forces of Arm Forces of the Philippine (AFP), under by National Bureau of Investigation (NBI) in-charge as a Royal Intelligence or personnel and personal or private or own Intelligence Forces of Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Philippine Royal Knights Intelligence”.

**Function and Responsibility;**

- (i) Serve as the Intelligence Group and Forces of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
  - (ii) Conduct services regarding on any Intelligence operative services of Philippine Empire and Kingdom of Philippine
  - (iii) Other as may provided by law.
- vi. **Royal police** - A Highly and honored Reserve Military Forces and Local Forces and Special Unit Arm forces of Arm Forces of the Philippine (AFP), under by Philippine National Police (PNP) in-charge as a Royal Police or personnel and personal or private or own Police Forces of Philippine Empire and Kingdom of Philippine, that holds the title and name of the “Philippine Royal Knights Police”.

**Function and Responsibility;**

- (i) Serve as the Police Forces of Gutierrez Empire, Philippine Empire and Kingdom of Philippine.
  - (ii) Conduct services Police operative services of Philippine Empire and Kingdom of Philippine
  - (iii) Enforcer of law of Philippine Empire and Kingdom of Philippine
  - (iv) Other as may provided by law.
4. Royal Military and Arm Forces of the crown, includes his Royal Knights and member shall have the rights to complain or file a case or depend, protect and exercise their rights in a Royal Court of Justice or administer justice as a Royal Knights and a loyal protector of Gutierrez Empire, Kingdom of Gutierrez, Philippine Empire and Kingdom of Philippine and its members and people against to any citizens, Government agencies, authorities, Arm Forces of the Philippine (AFP), includes their under organization the Philippine Army (PA), Philippine Navy (PA), Philippine Air Force (PAF) and National Bureau of Investigation (NBI) and Philippine National Police (PNP) if any violation or orders from this citizen, Government agencies, authorities, Arm Forces of Philippine (AFP) and soldier that makes violate their rights to protect or disobey and dishonor or

dis respect their services to the Empire and Kingdom as long that this services is authorized and approved by law.

5. To Declare and promote not less than 50 % percent of Reserves Forces or Military Reserve Arm Forces of Nation or Arm Forces of Nation will be under in control and command of Royal Military and Arm Forces of the Crown.

## **Chapter 5**

### **Article 5**

#### **ROYAL ARMS AND CROWNS, ROYAL IMAGES, ROYAL NAMES**

#### **Section 64**

#### **ROYAL ARMS**

1. To Declare the coat of arms and its uses as a symbol of royal arms of Philippine Empire and Kingdom of Philippine to be honored and respected among people and in under Philippine Empire and Kingdom of Philippine.
2. To Declare the coat of arms as the representation of Royal Crown.
3. To Declare the coat of arms as representation of his highness emperor-king and his family.
4. Unauthorized uses of royal arms will be subject, as a committing violation and insult to the Crown, and his highness emperor-king of Philippine Empire and Kingdom of Philippine and may be subject for punishment of having penalty or imprisonment order by the Royal Court of Justice.
5. Royal Arms that are registered under in the name and title of following;
  - i. Gutierrez Empire Arms
  - ii. Philippine Empire Arms
  - iii. Kingdom of Philippine Arms
  - iv. Royal Military Arms or Arm Forces of the Crown Arms
  - v. Kingdom of Gutierrez Arms
  - vi. Prince of Filipinas Arms
  - vii. Other as may provided Empire and Kingdom and authorize by law
6. Other as may provided by law

## **Section 65**

### **Use of Crown**

1. To Declare the Crown as a symbol of his highness Emperor-King of Philippine Empire and Kingdom of Philippine and representation of Philippine Empire and Kingdom of Philippine.
2. To Declare the Crown as most important and honored and respected figure in Empire and Kingdom.
3. Unauthorized uses of royal crown images will be subject, as a committing violation and insult to the Crown, and his highness emperor-king of Philippine Empire and Kingdom of Philippine and may be subject for punishment of having penalty or imprisonment order by the Royal Court of Justice.
4. Crown registered under in the title and name of the following;
  - i. Gutierrez Empire Crown
  - ii. Philippine Empire Crown
  - iii. Kingdom of Philippine Crown
  - iv. Kingdom of Gutierrez Crown
  - v. Other as may provided Empire and Kingdom and authorize by law
5. Other as may provided by law.

## **Section 66**

### **Royal Images and Names**

1. To Declare the use of Royal images and names of Royal Families of Philippine Empire and Kingdom of Philippines must be permitted and authorizes by Bureau of Royal Affairs.
2. To Declare that images of Emperor-King of Philippine Empire and Kingdom of Philippine must be presence and put in offices of nobles and houses.
3. Unauthorized uses of Royal Images and names will be subject, as a committing violation and insult to the Crown, and his highness emperor-king of Philippine Empire and Kingdom of Philippine and may be subject for punishment of having penalty or imprisonment order by the Royal Court of Justice.
4. Other as may provided by law



## Article 6

### CREATING OF CASTLE, PALACE AND HOUSES

#### Section 67

#### Declaration of Policy

##### Castle;

1. To Declare and/or there shall be a Castle, Palace and houses as a Home, and Offices of Emperor-King and appointed nobles of Gutierrez Empire, Philippine Empire and Kingdom of Philippine
2. To declare the name of Castle of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine as "Castle of Gutierrez" or *Castle ni Gutierrez* as also known as Castle of Filipino's Family's or Castle of Philippine or Philippine Empire and Kingdom of Philippine.
3. To Declare the Castle of Gutierrez to be the own and officially home and residence of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine and his family.
4. The Castle of Gutierrez, palace's and houses if or upon established under by the Government, and of implementing of this law if approved will be temporary under by own by Government and payed by the emperor-king and his family from his service and deduction of his salary until it is totally payed and under by his ownership.

##### Palace;

5. To declare the name of Palace of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine as "Palace of Gutierrez" or *Palasyo ni Gutierrez* as also known as Palace of Filipino's Family's or Palace of Philippine or Philippine Empire and Kingdom of Philippine.
6. To Declare the Palace of Gutierrez to be the officially Office and other residences of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine and his nobles.

##### Houses;

7. To declare the name of Houses of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom of Philippine as "Houses of Gutierrez" or *Balay ni Gutierrez* as also known as houses of Filipino's nobles Family's or Houses of Philippine or Philippine Empire and Kingdom of Philippine.
8. To Declare the houses of Gutierrez to be the officially Offices and other residences of Emperor-King of Gutierrez Empire, Philippine Empire and Kingdom appointed Nobles.
9. Other as may provided by law.

## **Article 7**

### **PROJECTS**

#### **Section 68**

##### **Declaration of Policy**

1. This is to propose to allow the Gutierrez Empire, Philippine Empire and Kingdom of Philippine and create or establish and manage own projects and programs as may provided and authorize by law.
2. Other as may provided by law
3. The projects and programs of the following constitution;

### **Royal School and Universities**

#### **Sections 69**

##### **Declaration of Policy**

1. This is to propose to allow Gutierrez Empire, Philippine Empire and Kingdom of Philippine and create or establish and manage own Royal Universities to be the Universities of Nobles and other people from primary or elementary, secondary or high school and colleges and universities as may provided and authorize by law and Department of Education and Commission on higher Education.
2. Other as may provided by law

### **Museum**

#### **Section 70**

##### **Declaration of Policy**

1. This is to propose to allow Gutierrez Empire, Philippine Empire and Kingdom of Philippine and create or establish and manage own Museum of Nobles and other people as may provided and authorize by law.
2. Other as may provided by law.

## **Article 8**

### **Symbols, Logo and Flag of Empire and Kingdom**

#### **Section 71**

##### **Declaration of Policy**

1. The Form and Symbol and belief or principle of Logo, crown of Philippine Empire and Kingdom of Philippine shall be determined by Gutierrez empire and by law.
2. The Form and color of the flag of Philippine Empire and Kingdom of Philippine shall be determined by Gutierrez empire and by law.
3. There shall be a Philippine Empire and Kingdom of Philippine Capital, shall be determined by Gutierrez Empire and by law.

## **Article 9**

### **Final Provision**

#### **Section 72**

##### **Rules and Regulation**

Upon The approval of this Act in within Six (6) Months The Office of the Vice President, The House of the Senate, House of Representative, The Department of Interior and Local Government (DILG), Department of National Defense (DND), Arm Forces of the Philippine (AFP), Bangko Sentral ng Pilipinas (BSP), Department of Foreign Affairs (DFA) shall submit and promulgate the implementing Rules and Regulation (IRR) of this act.

#### **Section 73**

##### **Fundings**

The Funding and necessary amount to implement the provision of this act shall be get from the Government Funds issued from the Department of Finance (DOF).

#### **Section 74**

##### **Suppletory Application or Appropriations**

The purposes of this Act, the Revised Penal Code and other applicable laws, shall have suppletory application.

## **Section 75**

### **Amendments or Revision**

Any amendments to, or revision of this act may be propose by Any appointed officials or nobles of Gutierrez Empire, Philippine Empire and Kingdom of Philippine that approved and authorized by Emperor-King Jorge Marlo Mira Gutierrez.

## **Section 76**

### **Separability Clause**

If any Sec. or provision of this Act is held unconstitutional or invalid, the other Sec.s or provisions shall not be affected.

## **Section 77**

### **Repealing Clause**

That All laws, Presidential decrees, executive orders and rules and regulations, or parts thereof, inconsistent with the provisions of this Act are hereby repealed or modified accordingly.

## **Section 78**

### **Effectively Clause**

This Act shall be effective fifteen (15) days from the date of its publication in Official Gazette or in at least two (2) newspapers of general circulation.
